Discounted range balls (\$5.00), 5% discount on merchandise in pro shop (excluding Balls) access to member tournaments, USGA GHIN service (yearly fee), online Membership Portal and 7-day advance tee times. Player can access a player charge account for purchases with credit/debit card on file.

MALLARD POINTE RULES, POLICIES, WAIVER AND RELEASE

I Agree to Abide by The Following:

- No outside food and beverages are allowed on the course. We have everything you need. Violators will be asked to leave with no refund.
- No Loud and abusive language in or around Clubhouse. Any abusive language directed towards other guests, members, or employees will not be tolerated and you will be asked to leave.
- No 5 some's at any time violators will be asked to leave without refund.
- All Players must Have their own clubs and will not be allowed to play out of another person's bag.
- **SLOW PLAY** creates problems. We ask that **EVERYONE** be considerate of others on the course. We will do everything we can to keep play moving.
- Mistreatment of Carts will result in suspension of privileges to play at Mallard Pointe with no refund to any player in the group and the players responsible will be charged the cost of repairing the cart.
- Carts must be in designated areas, no closer than 75 feet from greens and tees unless on cart path, no carts in parking lot, and please keep carts out of woods.
- Riding is required on Friday, Saturday, Sunday & holidays until 1:00 p.m.
- All Cart drivers must be a licensed driver to rent or operate golf carts.
- No children under 12 (without prior approval) until 1:00 p.m. on weekends and holidays.
- Proper golf attire is required – no boots, blue jeans, blue jean shorts, cutoffs, athletic shorts, tee shirts, tank tops, etc.
- Singles and Doubles will be paired together.
- All rules and policies are subject to change and will be posted if changed.
- Players with riders will be charged a rider Fee of \$20 on Fridays, Saturdays, Sundays and Holidays. (Including Members)

I hereby agree to participate and/or engage in the use of the course, equipment, facilities, and programs offered by Mallard Pointe Golf upon the understanding and agreement that:

- 1) I understand that this is a Player Pass and not a membership even though there are some similarities between the two and I agree to the terms of the Player Pass.
- 2) I am aware of the risks of illness or injury in any golf or exercise activity. These injury risks include but not limited to; being hit by a golf ball or balls, golf clubs, golf carts, lightning, stepping or tripping in holes or other natural indentations in the ground; injury from insects, animals, birds, snakes, or drowning, walking up hills, descending hills: pulled muscles or other sprains/strains or injuries. I am Participating under the express understanding that I hereby indemnify, defend, waive and release Mallard Pointe Golf, its employees, agents, officers, directors, successors and assigns from any claims, cost liability, expenses or judgements including attorney fees and court cost (hereafter referred to as "claims") arising out of my participation and the participation of my family and guest at any event of Mallard Pointe Golf Course.
- 3) Mallard Pointe Golf Facilities will be maintained to allow for normal golf activities. There is no guarantee as to the condition of the course or any amenities included in this agreement. Players will have access to amenities listed in this agreement subject to availability, which is to be determined by the sole discretion of Mallard Pointe Golf. Certain private and public events may dictate that the golf course, practice area, snack bar, and or other areas of Mallard Pointe Golf Course be closed. All players understand and agree that nothing in this agreement shall entitle the player to any of the facilities on any given day nor to a discount or refund on account of limited access. Player further understands that access to the course, practice facility, snack bar and other benefits may be limited by Mallard Pointe Golf as necessary to maintain facilities and golf course. No player is entitled to a refund or return of amounts due to damage to or the condition of the golf course because of maintenance, acts of God and or vandalism. Further Mallard Pointe Golf shall have no liability for temporary suspension of any privilege due to maintenance, repair, construction, improvements, acts of God, inclement weather, utility disruptions or any and all other matters beyond control of Mallard Pointe Golf and Management.
- 4) GOLF CART AGREEMENT. The pass holder acknowledges that he/she is aware that golf carts are an amenity available to the pass holder. The fee for golf cart rental is \$20.00 for 9 or 18 holes and the privilege may be taken away at any time by MPG&V management or staff for mistreatment of golf carts with no discount or refund. The pass holder warrants that the He/she is familiar with the operation of the golf cart and is 16 years of age with a valid driver's license. The pass holder agrees to return said golf cart at the end of play in as good of condition as received. Pass holder Further agrees to reimburse MPG&V for all damage incurred during the use of a golf cart by either the pass holder or authorized rider.
- 5) This waiver constitutes the full and entire agreement between the parties hereto and such parties acknowledge that there is no other agreement, oral and or written, between the parties hereto.
